 - i. Advisor Ballard: I would like to motion for Dr. Golz to discuss the reserve as an open forum during my report time. 6 minutes.

- ii. Dr. Golz: You have over \$700,000 in the reserve. You only budget 75% of your budget each year and, the other 25% always goes to the reserve for incidentals. Also any money you do not spend is swept into that reserve fund at the end of each year. I understand in the past that number has always been reported substantially less. There was a misconception that it could not be reported, because it may be swept by the university. So I began to ask questions, and saw that the money cannot be swept without you giving proposals of how to spend it. The Dean of Students and the President have final say, but if proposals are responsible and fiscally sound they should be approved.
- iii. Senator Kyser: Has there been any discussion of an audit to look into this money and the accounting? I want to make sure the accounting was done properly and been used properly. It is hard to keep accountability among senators so I think there should be a more long term look at this money.
- iv. Dr. Golz: I could ask for the records to see like 5 years back if you would like?
- v. Senator Ligier: Is there any interest on this count?
