- n. Wesley
 - i. When you said something about beautification. We missed the first 3 days because of the cold weather. Facilities did not do anything preventative to protect plants and things on campus to protect them from freezing. Did they take care of that.
- o. Nicklow:
 - i. Yes, they give most of the plants, had have donated a lot of the things to the campus. I would be surprised if an organization or institution was able to prevent something like that.
- p. Jack Driftwood
 - i. What are your plans to do with Driftwood's debt.
- q. Dr. Nicklow
 - i. I hope that SGA and the Driftwood can have some serious conversations about the debt. I think the Driftwood needs to develop a serious business plan, to become sustainable. I love having a newspaper, I don't want to close it. But that

what will happen if there is no plan. You cannot solve it in one year, but you need to develop a plan to get out of this debt over the next few years. At my previous institution we were in a similar situation, and they were able to find sponsors. What about sponsorships, and do we move online or partly online. It is a student newspaper, and I think SGA can really help with that.
