- 3. Update from Faculty Senate President (Nicola Anthony)
 - * Be on the lookout for faculty disciplinary committee elections- need members form each college.
 - *Liz Land (President's Office) has a copy of the faculty appointment policy.
 - *Budget committee meeting will be forthcoming. Look for invitation from chair James Logan
 - * Seeking clarity from registrar's office if the new teaching evaluation form approved by faculty senate in Spring 2019 will be in place for Fal 2019.
 - *UNO Director of Web Strategy will attend October faculty senate meeting with updates on website revisions.
- 4. News from the UNO Office of the President (John Nicklow)
 - *UNO Enrollment up 1% from last fall--- first back-to-back increases in 10 years.
 - * Full-time undergraduate enrollment up 2% (3rd straight year of increases)
 - * Areas for improvement are international student and graduate students
 - * Some tactical adjustments on recruitment will be occurring
 - * A recent \$2 million anonymous donation to UNO has been announced.
 - * UNO Foundation is helping with a fundraising campaign to be launched soon
 - * B. Bollinger offering matching grant to replace roof on engineering building.
 - * DXC gave \$500,000 last year and will give \$1.5 million this year, including faculty supports.
 - * Spoke w/ GNO) Inc. last week, and next week will speak with N.O. Business Council.
 - * Reminders: Hitt Lecture 6:30 PM tonight
 - Dr. Henderson of UL System on campus 10/8 to discussion future of UL system and the legislative agenda.

Questions to the President:

- R. Stufflebeam asks about changes in dual enrollment
- T. Wang asks about removing out-of-state fee for int'l enrollments. Response is that this hasn't been done yet due to potential financial risk.
- N. Anthony asks about graduate enrollments and relation to new application management



process. Response from Provost: Apps will go straight to departments hopefully boosting turnaround time. New hire is already working (internal hire) primarily on graduate admissions.

- 5. Description and process for populating the <u>Senate Administrative Board Disciplinary</u> <u>Committees</u>: Grievance Review Committee, Charges Committee and Hearings Committee. *College elections being held now.*

 - Current activities include Policy on academic level of courses (1000, 2000, etc.), policies on online, hybrid, face-to-face courses, as well as the appropriate amount of contact minutes for an online course.

 Have not met yet this year, but will do so soon. Plan to investigate pay equity by gender.
- 7. ULS Committee member needed from the faculty senate

 This multi-campus group will look at core competencies for 21st century. N. Anthony and D.

 Payne standing in for now. Dean Long as well. Interested parties see N. Anthony.
- ORSP Internal Grants Program overview (Carol Lunn, Office of Research)
 *Innovate UNO deadline extended until 10/2. Grad submissions down, UG submissions up.
 Awards to be given in both categories.

*UNO Internal awards were announced 8/14. Due in December- after BOR grant deadlines.

Tenured and tenure track faculty may apply, but may only have 1 open internal grant at a time.

New grant writers have been hired, but will not assist with internal awards--- but may help converting internal grant proposals into an external grant.

These include Travel Grants, International University-University partnerships, LEEP grants to bring external expertise to campus, and Travel grants to meet with program officers.

- * Faculty awards will be due in December. Chairs and Directors can now nominate.

T. Wang: Recently approved Review, Promotion, and Tenure document states that college level P&T committees have 1 member per department. Does this mean "at least 1" or "only 1".



Consensus of the faculty is that this means "only 1"

The Student technology fees has some funds, and the committee will be making expenditure decisions on these soon. R. Dupont suggests a member of the Faculty Senate academic board be placed on the technology fee allocations committee.
