Quorum was established for undergraduate and graduate voting.

The meeting minutes from the 10-28-19 along with pending proposals were reviewed and voted upon via the UCCC Moodle page. They will be posted to the UCCC website.

A&S 4000 – The department submitted a revised syllabus.

The AVIA course proposals will remained tabled until additional information is provided from the College of Business.

BIOS 4453/5453 and BIOS 4933/5933 – Per the chair, Dr. Schluchter, the graduate courses will be restricted by program and other graduate students would need permissions. The grading scale of R was in error and should have been an F. Updated proposals were submitted.

CHEM 6620 and PHYS 6620: The departments will add department consent as the prerequisite.

CSCI 4452/5452 & ENEE 3571; ENEE 4583/5583 – Both departments affirmed their support of the proposals. The Electrical Engineering Department does indeed agree to include the statement "May not be taken for credit by Computer Science majors." in the course description.

ECON 1330 - The department submitted an updated syllabus.

CSCI and Math Undergraduate Certificates – Both departments' submitted responses to the committee which confirmed that non-majors would be allowed to pursue the certificates. Upon further discussion, the committee would the departments to submit a certificate mapping schema similar to the recommended 4 year plan that outlines the sequence of classes and timeline for completion. Ms. Berry will contact the departments.

Ms. Athey discussed concerns regarding the reintroduction to the accelerated masters' program. Several details need to be determined including the number of credit hours that can overlap between both programs, the total number of credits earned during the graduate career, and addressing those students who do not meet the requirements to continue in the graduate program. Ms. Athey will send an email with additional considerations.
