Their core areas of interest are: Human capital and well-being, particularly whether economic inequality affects the development of human capital, and to what extent the institutions that support human capital development mitigate inequality's potential impacts; The labor market, particularly how technology, labor policies, discrimination, and changes in the labor market, such as fissuring, affect worker outcomes; Macroeconomic policy, particularly the implications of the large and sustained increase in inequality for the long-term stability of our economy and its growth potential; Market structure, particularly the role of market structure in determining economic growth and its distribution, and the incidence and consequences of increased market power in the economy.

Academic letters of inquiry are now due February 12, 2020. Solicitations are open to researchers affiliated with U.S. universities.
