

EXTENSION OF TENURE PROBATIONARY PERIOD DUE TO COVID-19 PANDEMIC

Faculty hired into a tenure-track position in AY 2020-2021 or earlier may request a one-year extension of the tenure probationary period due to disruption caused by COVID-19. This extension will be granted to any eligible faculty member who applies for it. The deadline to apply is **June 30, 2021 (November 30, 2020 for faculty members who are eligible for tenure in AY 2020-21)**.

Eligibility:

Faculty who are scheduled to apply for tenure in AY 2025-2026 or earlier.

This COVID-related extension of the tenure probationary period is distinct from the existing Tenure Clock Stoppage policy outlined in <u>AP-AA-21.4</u>. Being granted a COVID-19 related extension does not exclude a faculty member from applying for Tenure Clock Stoppage outlined in AP-AA-21.4.

Application Process:

- Request for an extension should be made in writing, utilizing the attached form. It must be
 endorsed by the department chair and college dean, and submitted to the Associate Provost for
 Faculty and Diversity Affairs.
- A request can be made anytime up until June 30, 2021, with the exception of faculty who are eligible for tenure in AY 2020-21. The deadline to request for an extension for this group is November 30, 2020.
- Once granted a COVID-19 extension, a faculty member may return to their original tenure review
 date by submitting written notification of their intent to the department chair no later than June
 30 of the year that the initial tenure process begins (December 1). The notification should be
 forwarded to the college dean and then to the Associate Provost for Faculty and Diversity Affairs.

This policy does not apply to:

- Tenure applications under review in the current year (AY 2019-2020)
- Renewal of non-tenure-track appointments
- Annual faculty reviews
