### Harvard Dataverse Resources for COVID-19 Study

The COVID-19 virus presents unprecedented challenges, but also provides a rare opportunity for studying that, if seized, will help us understand future risks. Researchers from the Center for Geographic Analysis at Harvard University, the Geo-computation Center for Social Sciences at Wuhan University, RMDS Lab, and the Chinese Data Institute have built a web based platform for sharing research data on COVID-19, hosted on Harvard's Dataverse. The publicly accessible data includes daily statistics on the virus cases, inter-region migration data, local health facilities, social media data, demographic, business, population, and economic data mapped to administrative units.
