Um, he said I have received your compound resolution submitted September 6 2020. In support of declaring November 3 2020. A class holiday, I am pleased to see the SGA take leadership role in encouraging our student body to be engaged citizens who participate in the democratic process by voting and even registering to assist at the polls on Election Day. After reviewing the academic calendar, I have determined that it is possible to cancel classes on the day without any negative impact on meeting instructional requirements. Additionally, I agree that we have an obligation to be engaged citizens and I support the notion that cancelling classes on November 3, would increase opportunities for students to vote and potentially assist at the polls on election day. He added like a link to how to apply to be Election Day poll workers. And then he said therefore, the university will cancel classes on November 3 2020. However, I do have one condition to add, as SGA in partnership with other organizations on campus must develop and implement a campaign to encourage students to register and vote. I look

forward to engaging in this important work with all of you. Um, on that note, we do have the civic engagement coordinator in our office who posts things on our social media every Tuesday, besides this Tuesday because of the hurricane, but he usually post things every week. His name is Travonte. He is also works in the office Tuesday, Wednesdays and Thursdays. And if you want to come in and register to vote or need information register to vote, we have that outside as well as you can talk to him. Um, just to clarify that we do have something for our organization to help with voting and registering to vote. Um, so that's that I will send or I will forward the response to y'all if y'all would like to see it, um, especially Amber. So she doesn't have to type all of that. Um, and so next business is we have a donation drive for our SGA for hurricane Laura victims. So I know that I previously mentioned that we will be doing a Thanksgiving drive in collaboration with all the UL system schools, but I wanted to do something else, because that drive was so far out. So we will be partnering with Second Harvest, which is an organization who collects things like food, and canned goods like that to donate, and they have a, I guess a campaign that they are doing to send to hurricane or victims. And we're not just donating to anyone or not bringing in ourselves stuff like that. I will make a poster to put on Instagram. I would love it if you always share it all over the place because we will give out prizes for people who donate, we have three prizes, it will be two \$25 gift cards and then a, UNO, swag package thing. That sorts Um, so basically the way it works, you come in you donate your canned foods or whatever will be on the list. We will add your name to another list. And on October 16, we will do an Instagram Live drawing of three names. And those three names will get those three prizes. 




