

Law Enforcement (Community Police) Exemption

General Guidelines and Procedures

A resident of the State of Louisiana who is an active-duty sworn, commissioned peace officer who is a police officer or sheriff in Orleans or any of the seven neighboring parishes of Jefferson, Plaquemines, St. Bernard, St. Charles, St. James, St. John, and St. Tammany, is entitled to enroll at the University of New Orleans at the special fee of \$111 per three-hour course plus the required fees. This fee exemption covers the remainder tuition, registration, and off-campus fees not paid by the student.

The fee exemption is limited to six (6) credit hours per semester for undergraduate level courses that are needed to obtain one degree and also graduate level coursework. This exemption may be used during the summer term.

At the end of each semester, the student is required to maintain a minimum cumulative 2.0 grade point average. Students who fail to meet this cumulative grade point average will be required to make payments until eligibility is regained.

If a student receives and "I" (incomplete) grade, it should be changed to a letter grade in accordance with the Registrar's office guidelines (<u>www.registar.uno.edu</u>) for retention evaluation purposes.

If the student withdraws/resigns after the 15th class day, the student may be required to file an appeal to receive the fee exemption in the future. For details regarding the appeal process, you may contact the Office of Enrollment Services at (504) 280-6595.

To apply, complete the verification form, attaching a copy of your commission and badge, and submit to the Office of Enrollment Services at least seven (7) days prior to fee payment date.
