COVID-19: Pre-Departure & Flight

- COVID-19 Booster required if primary round of vaccination completed before November 15, 2021 (270 day validity) otherwise strongly recommended by CDC. Send proof to UNO-Innsbruck.
- Read CDC recommendations for international travel.
- Immunocompromised individuals at increased risk for severe COVID-19 should discuss travel plans with doctor and UNO-Innsbruck program administration.
- 7-10 days prior to departure safeguard against contracting COVID-19 by masking, distancing, and good hygiene protocols.
- COVID-19 test before departure is encouraged. If positive, do not travel! Inform UNO-Innsbruck and insurance.
- Flight: N-95 mask highly recommended and possibly required on flight. Bring one!
- Entry Germany/Austria: Proof of full COVID vaccination in official paper or digital form: CDC card, vaccine record from health care provider, LA wallet, etc. Note: Photo of paper form not acceptable!
- You do not need a "pre-travel clearance" or "entry registration" form if fully vaccinated.

COVID-19: During Program

- "3G" rule (vaccinated, recovered or tested) no longer applies during your stay in Austria.
- Mask Mandate: University, public transport (incl. at train stations and airports), taxis, and essential shops (e. g. supermarkets, post offices and pharmacies).
 Note: required masks are "FFP2 masks" = N95 masks. Bring several!
- If symptoms, test! Report positive result to UNO-Innsbruck admin. Obligation to report.

 Bring 5 tests! In Austria, approx. \$10-30 for antigen tests, \$50-100 for PCR tests. Order free test kits here.
- If you contract COVID-19: Quarantine in a single room in program housing facility for up to 10 days. We coordinate meal delivery of incl. breakfasts and lunches. Delivery services exist for other meals. Friends can help! We will facilitate continued learning to the best possible extent.
- Weekend travel: Follow <u>State Department advisories</u>!
 Complete weekend travel log before departure. Inform yourself of any COVID restrictions and guidelines. Wear N-95 masks on transportation and in crowded settings.

COVID-19: Departure to U.S.

• ALL travelers to the United States — including U.S. citizens — must provide proof of a negative COVID-19 test (antigen rapid or PCR) taken within ONE CALENDAR DAY of departure, or proof of recent recovery.

- If you test positive and are unable to depart, the dormitory in Innsbruck will allow you to stay and quarantine the required number of days.
- The cost of lodging, meals and fees for airfare changes will be covered by the Travel Delay benefit of our insurance (maximum of \$2,000 subject to \$200 per day).
- Keep documentation of your positive COVID test as well as copies of your lodging and meal receipts.
