COMPLAINT (include all important information, i.e. facts, dates, times, witnesses, etc.):

On August 31, 2022, the Plaintiff was placed on the Agenda of the SGA Senate for consideration to be appointed to an open Senate seat {Exhibit A}. The Plaintiff was notified about the SGA Senate Meeting through an e-mail dated August 30, 2022, from the Vice President of Legislative Affairs Azizah Hinnawi. However, when the Plaintiff looked at the SGA's website, he noticed that the last Agenda posted for the general public to access was dated May 11. 2022 {Exhibit B}. Further, as of the date of the filing of this Petition, the Agenda for the SGA Senate Meeting of August 31. 2022, is still not posted for public access on the SGA's website {Exhibit B}. On August 31, 2022, after the Plaintiff gave a 3 minute speech, numerous SGA Senators had questions to ask the Plaintiff, as his speech had apparently generated much interest and controversy. The SGA Senate then voted to extend the questioning period for an additional 3 minutes. When the second 3 minute round of questions ended, Vice President of Legislative Affairs Azizah Hinnawi abruptly and unilaterally ended the questioning period and would not allow SGA Senators to extend to a further third 3 minute round of questions. At this point, the Plaintiff left the room and waited outside as the SGA Senate considered and debated his appointment. At some point, a group of Freshmen students, who had been observing the SGA Senate, exited the room and expressed their displeasure at being "kicked out" because the SGA Senate went into Executive Session to discuss the Plaintiff's appointment. At some point later, the Plaintiff was called back into the room by Assistant Director Todd Gitlin. Vice President of Legislative Affairs Azizah Hinnawi then informed the Plaintiff that he had not been appointed to the SGA Senate.

The Plaintiff submits to this Court that there were several procedural violations of the SGA Senate Rules and Procedures and The Louisiana Open Meetings Law committed by the SGA Senate and the Vice President of Legislative Affairs Azizah Hinnawi during the Senate's debate and consideration regarding the appointment of the Plaintiff to the SGA Senate. First, the SGA Senate Rules and Procedures Section 3.9,, Subsection 3.9.2, states that Executive Sessions are governed by R.S. 42: 16, 42:17, and 42:18 of The Louisiana Open Meetings Law, R.S. 42:16 of The Louisiana Open Meetings Law states in pertinent part that, "A public body may hold executive sessions upon an affirmative vote, taken at an open meeting for which notice has been given pursuant to R.S. 42:19." R.S. 42:19(b)(i) states "All public bodies, except the legislature and its committees and subcommittees, shall give written public notice of any regular, special, or rescheduled meeting no later than twenty-four hours before the meeting." Therefore, since the SGA Senate and the Vice President of Legislative Affairs Azizah Hinnawi failed to timely post a 24-hour notice of the Agenda for the August 31, 2022, SGA Senate Meeting to its website. notifying the public of said SGA Senate Meeting, an Executive Session could not have been legally entered into. It is important to note that, for the purposes of The Louisiana Open Meetings Law, the term "legislature" refers to the Louisiana State Legislature and not any legislative body, such as the SGA Senate. Also, R.S. 42:17(1) states in pertinent part that, Discussion of the character, professional competence, or physical or mental health of a person, provided that such person is notified in writing at least twenty-four hours before the meeting and that such person may require that such discussion be held at an open meeting. However, nothing in this Paragraph shall permit an executive session for discussion of the appointment of a person to a public body..." Therefore, since neither the SGA Senate nor the Vice President of Legislative Affairs Azizah Hinnawi notified the Plaintiff 24-hours prior of an Executive Session to discuss his character, professional competence, or physical or mental health, an Executive Session could not have been legally entered into on August 31, 2022, during the SGA Senate's debate and consideration to appoint the Plaintiff to the SGA Senate. Additionally, R.S. 14:17(1) states in pertinent part that, "However, nothing in this Paragraph shall permit an executive session for discussion of the appointment of a person to a public body..." Therefore, since the SGA Senate was discussing the appointment of the Plaintiff to the SGA Senate, which is a public body, the SGA Senate could not have legally entered into an Executive Session to discuss the appointment of the Plaintiff on August 31, 2022. Furthermore, R.S. 14:17(1) states in pertinent part that, "... and that such person may require that such discussion be held at an open meeting." However, neither the SGA Senate nor the Vice President of Legislative Affairs Azizah Hinnawi provided the Plaintiff with the legal option on August 31, 2022, to have the portion of the debate heard during an Executive Session, to instead be heard during an open meeting. This failure on the part of the SGA Senate and the Vice President of Legislative Affairs Azizah Hinnawi to allow the Plaintiff to choose an open meeting, rather than an Executive Session, is a violation of R.S. 14:17(1) of The Louisiana Open Meetings Law. Further, SGA Rules and Procedures 3.7.10 Nominations and Appointees, Subsection 3.7.10.1, states in pertinent part that, "Any senator has the right to question any nominee or appointment in which a senate confirmation vote is needed. Any nominee or appointment shall have the opportunity to speak on the matter if they so choose to." Therefore, since there were clearly additional SGA Senators who still had questions to ask the Plaintiff during the questioning sessions on August 31, 2022, the Vice President of Legislative Affairs Azizah Hinnawi abused her authority by unilaterally ending any further questioning. As previously stated in this Complaint, the SGA Senators had voted to extend the first 3 minute round of questioning to a second 3 minute round. When the second 3 minute round expired, the Plaintiff was finishing up one answer and was in the process of moving on to accept another Senator's question when Vice President of Legislative Affairs Azizah Hinnawi abruptly and unilaterally stopped any further questions or answers or the ability of interested Senators to extend to a third 3 minute round of questioning. This is despite the fact that the Plaintiff was willing to answer additional questions and Senators clearly had additional questions to ask the Plaintiff. The Plaintiff submits to this Court that this is a violation of SGA Rules and Procedures 3.7.10.1 by the Vice President of Legislative Affairs Azizah Hinnawi. The Plaintiff further submits to this Court that if, in fact, additional rounds of questions would have been allowed by the Vice President of Legislative Affairs Azizah Hinnawi, the Plaintiff could have answered the questions of additional Senators and the need to move into an Executive Session could have been eliminated.
