Meeting Minutes – September 30, 2019

Quorum was established for undergraduate and graduate voting.

The committee welcomed new members Dr. Akyuzlu and Dr. Jilkov from the College of Engineering, Dr. Dufrene from the College of Liberal Arts, Education, and Human Development, and Lindsey Reno from the library.

Dr. Dufrene and Dr. Derstler to attend the meetings in person due to their teaching schedules. They will vote via Moodle or by proxy.

Dr. Green was re-elected as the committee chair. Ms. Reno was elected as the committee vice chair. Ms. Berry will continue to serve as the recording secretary. Prof. Hansen tentatively agreed to serve as the syllabi reviewer.

The committee reviewed the list of proposals that were approved since the committee last met in May 2019. There were 3 one time waivers, 2 activations, 3 new courses, and 1 updated graduate certificate program.

Dr. Akyuzlu raised concerns regarding the title of CSCI 6454 – Parallel and Scientific Computing. Ms. Berry and Ms. Athey raised concerns that the description lists 3 undergraduate courses as prerequisites for a graduate level course. Ms. Berry will email the department with those concerns. The matter of undergraduate courses being listed in the descriptions for graduate courses will be a future clean-up process for the catalog.

Dr. Noyes indicated that the General Education committee will hold its first meeting next month.

Ms. Berry gave a brief overview of the UCCC survey that was sent to the department chairs and college deans. There is an overwhelming need for better communication between the UCCC and the colleges regarding the location of pending proposals. Though there is interest in the purchase of a catalog and curriculum management software, there were concerns regarding future budgets.

Ms. Berry also confirmed the upcoming deadlines for proposal submissions.

Discussions regarding Lower Division/Upper Division Courses, and Undergraduate Certificates were tabled to the next meeting.
