

University of New Orleans (UNO) Campus Hazing Transparency Report

Last Updated: July 1, 2025

As required by **Louisiana Revised Statutes §17:1801-1806 (Max Gruver Act)**, the **Stop Campus Hazing Act (Act 472)**, and **federal reporting requirements**, the University of New Orleans provides the following information regarding **hazing allegations involving student organizations**.

This report reflects any **alleged hazing violations** reported to the institution since **July 1, 2020** and is updated **at least twice per year**, in accordance with state law. It includes allegations **regardless of whether the organization was officially recognized at** the time of the incident and whether or not the investigation resulted in a finding of responsibility.

Required Hazing Prevention Training

In compliance with **Louisiana Revised Statutes § 17:1801.1** (Act 640, Max Gruver Act), every recognized student organization must annually provide **at least one hour of hazing prevention education** to all members, new or continuing. This training must cover institutional and state hazing policies, reporting protocols, and criminal penalties. Each organization must also report completion via an attestation form.

There have been no findings of responsibility for hazing-related allegations involving student organizations at the University of New Orleans within the past five years. During this time, any reports received have either been unsubstantiated, resolved informally, or determined not to meet the definition of hazing under university or state law.

Definitions

Hazing is defined as any intentional, knowing, or reckless act, occurring in a group context, regardless of willingness to participate, that causes or creates a substantial risk of physical or psychological harm, and is committed in the course of an initiation or membership process.

This includes actions associated with recognized or unrecognized student organizations such as:

- Fraternities and sororities
- Club or varsity sports teams
- Bands, student government, or any registered student group

Reporting Hazing

UNO does not tolerate hazing in any form. Anyone with knowledge of hazing activity is strongly encouraged to report it.
